The Committee removed R4-11-601, 607 and 608 from the draft NPR since there were no proposed changes.

The Committee proceeded to review Article 12 and modified R4-11-1203 to reference Section 1301, 1302, 1303 and 1304 permits.

The Committee concurred to review Article 13 at the next meeting.
