## NOTICE OF MEETING OF THE ARIZONA STATE BOARD OF DENTAL EXAMINERS’ INVESTIGATIVE COMMITTEE

Pursuant to Arizona Revised Statute (“A.R.S”) § 38-431.02, notice is hereby given to the members of the Arizona State Board of Dental Examiners’ (“Board”) **Investigative Committee** (“Committee”) and to the general public that the Committee will hold a meeting open to the public on **Tuesday, January 31, 2023 at 1:00 p.m.** The meeting will be held in virtual and telephonic formats. The executive session is not open to the public.
